Responsible for on-site leadership of vehicle repair and maintenance. Perform major mechanical repairs with no supervision to ensure proper performance and safety of all district vehicles.

Major Responsibilities and Duties

- 1. Process and prioritize vehicle repair work orders.
- 2. Evaluate and recommend all repairs.
- 3. Arrange for outside repairs when work cannot be performed in shop.
- 4. Supervise and manage mechanics job performance.
- 5. Assign work to vehicle mechanics, mechanic assistants, and bus maintenance workers.
- 6. Oversee completion of work and inspect completed work for quality.

- 7. Establish preventive maintenance and care schedules.
- 8. Consult with other mechanics to help resolve repair problems and help train mechanics.
- 9. Perform major and minor mechanical repairs, preventative maintenance, diagnostics, and inspections on all district vehicles in a timely and efficient manner, without supervision.
- 10. Maintain accurate, up-to-date preventative maintenance records.
- 11. Rebuild, replace, or repair vehicle parts such as engines, brakes, transmission lines, electrical assemblies, and accessories.

Inspection:

12. Perform state safety inspections for all district vehicles.

Safety:

- 13. Follow established safety procedures and techniques to perform job duties, including lifting and climbing.
- 14. Operate tools, equipment, and machinery according to prescribed safety procedures.
- 15. Ensure shop, equipment, and tools are kept in safe operating condition.
- 16. Correct unsafe conditions in work area and promptly report any conditions that are not immediately correctable to supervisor.
- 17. Follow district safety protocols and emergency procedures.

Other:

- 18. Conduct annual inventory of equipment and supplies.
- 19. Recommend replacement of equipment when needed.
- 20. Assist in compiling department budget.
- 21. Compile, maintain, and file all reports, records, and other documents as required.
- 22. Operate bus and vehicles as needed.
- 23. All other duties as assigned by supervisor.

Supervisory Responsibilities:

Direct the work of lead mechanic, mechanics, and vehicle general maintenance workers.

Tools/Equipment Used: Automotive diagnostic equipment; wheel balancing equipment; tire repairing equipment; small hand tools; power tools; welding torch; torque wrench; jack an life equipment; computers and peripherals; school bus and district vehicles
