- 3. Complete all classroom instruction for new trainees utilizing Learning Management System (LMS).
- 4. Complete DPS Road test to obtain CDL.
- 5. Attend 20-hour Texas School Bus Driver Safety Training Course as assigned

- 6. Anticipate problems such as traffic, weather, road conditions, and schedule changes and make necessary adjustments to ensure student safety and reduce delays.
- 7. Follow assigned bus route as directed.
- 8. Display professionalism in dealing with students, parents, staff, and community.
- 9. Approach problem solving tactfully with directness and integrity.
- 10. Exert a positive influence and work in harmony with associates.
- 11. Respond to suggestions for improvement in a positive manner.
- 12. Observe all traffic laws and safety regulations for school buses.
- 13. Keep assigned bus clean as required
- 14. Maintain professional appearance.
- 15. Be mentally alert and physically able to perform all job functions.
- 16. Report all accidents to proper authorities with required information and within the appropriate period.
- 17. Manifest support for and compliance with the philosophy, policies, and procedures of Garland ISD.
- 18. Follow district policies and departmental procedures pertaining to individual assignments.
- 19. Be consistent in route departure/arrival times at designated bus stops.
- 20. Maintain discipline and use appropriate and effective behavior management control over groups of students.
- 21. Report student discipline problems to the appropriate administrator as required.
- 22. Perform other duties as assigned.
