3. I understand that if my student is recommended to take a CBE for grade acceleration, he/she must score at least an 80% or higher on each of the four content exams (Reading/Language Arts, Math, Science, and Social Studies) is required to accelerate a grade level. \_\_\_\_\_
4. I understand that if my student qualifies to take CBE/Acceleration exams in order to accelerate through the next grade-level, **my student ONLY has two lifetime opportunities to accelerate per grade level**. \_\_\_\_\_
5. My student will have to make an 80% on ALL four tests during the same window. **Should my student not make an 80% on all four exams, my student will have ONE more opportunity to test, but it can't be during the same window, and my student will have to take ALL four exams again even the ones he/she passed with an 80%. There is NO appeal process.** \_\_\_\_\_
6. Should my student qualify to move forward with CBE/Acceleration testing, then testing will take place the first week of June. I will have a choice for my student to either take two exams a day over a two-day period or one exam a day.

7. *Two-day testing: Day 1- Reading/Language Arts & Science. Day 2- Math & social Studies. One day testing (over four days). Day 1- Reading/Language Arts, Day 2- Math, Day 3- Science, Day 4- social studies.* \_\_\_\_\_
