## TRANSPORTATION

We will bus to all football games, basketball games, performances off campus, etc together unless otherwise notified. If a cheerleader is coming to a cheer event late due to the participation in another UIL event, a parent may bring them but they will ride back to campus on the team bus.

## **CHEERING ACTIVITIES**

In accordance with UIL rules, high school cheerleading squads are only permitted to cheer at one contest per school week. It would not be a violation for cheerleaders to cheer at a double header (two contests at the same site on one school night) or to participate in a pep rally prior to a contest and also lead cheers at the contest even though both occur during the school week. Friday night and weekend contests do not count toward the one contest per week rule.

## **CHEERLEADER COMPETITION**

The expectation is that all cheerleaders will participate in competition. Failure to commit and participating in competition(s) can result in removal at semester. Tryouts may be held to determine competition groups etc. A separate handbook, approved by the campus principal, will be given to each competition member. Each high school team is required to attend UIL Spirit. The date for UIL is not set until after school starts, but is typically held in January.

## PARADES

Participation in the Martin Luther King Parade and Labor Day Parade is mandatory.

## FOOTBALL

A. Varsity cheerleaders will cheer at all varsity games.

B. JV cheerleaders will cheer at all JV games at the sponsor's discretion. You may choose to cheer for the A or B team.

C. JV cheerleaders may be asked to cheer at additional varsity games at the discretion of the campus.

D. Freshmen games will be covered if there is a JV B squad.

E. Playoff games will be covered.

## VOLLEYBALL

A. Games can be covered by any squad at the discretion of the campus administration and sponsor.

B. Playoff games should be covered.

## BASKETBALL

A. All district varsity boys and girls games should be covered. Squad assignments will be at the discretion of the campus administration and the sponsor.

B. If a campus has a JV B squad, they will be assigned either JV or freshmen games.

C. Exceptions to the above rules are as follows: a. No out of town games on Monday

through Thursday nights. b.No cheering during the holiday break.

D. Playoff games should be covered.

## **OTHER ACTIVITIES**

Additional activities such as community events, etc. will be at the discretion of the sponsor and the campus principal. Cheerleaders are required to attend each of these events.

## **ESTIMATED CHEER COSTS**

\*\* Actual costs will vary depending on squad sizes and availability of items \*\*

The estimated cost of cheerleading for one year is outlined below. Every effort has been made to keep these costs to a minimum. Final costs will be sent ASAP after squad numbers are finalized and I get that info back from the vendors.

#### Varsity Cheerleader Cost Estimate- \$1400 Junior Varsity Cheerleader Cost Estimate- \$900

First Payment- \$500 at New Squad Meeting March 26, 2024 @ 6:30 pm.

Second Payment of \$500 for Varsity or remaining balance for JV is due April 23, 2024 @ Practice.

Final Payment for Varsity of remaining balance is due May 21, 2024 @ Practice.

All costs must be paid on time as we have deadlines for purchases to receive items in time for camp.

#### Refunds will not be given after items are purchased.

GISD provides uniforms, but the girls are responsible for all alterations needed and any damages to the uniforms that may have occurred throughout the year.

GHS provides the paper for signs. All other supplies for painting signs will be paid for by the cheerleader.

## 24-25 GHS Cheer Hair & Make Up Policy

GHS Cheerleading will have a set hair and make up policy to keep everyone in uniform. For the various activities' cheerleaders do, there will be different expectations for hair and make up. Presentation is an incredibly important part of enhancing a cheerleader's presence and building the atmosphere of a performance.

#### Hair Expectations

Hair expectations will be followed or cheerleaders will be benched. For example, if a cheerleader is told to have their hair up in a high ponytail there cannot be loose hairs left out around the face to "be cute". Hair is expected to be all the way up per the instructions given. Additionally, hair can only be natural colors. Examples: blonde highlights or dark brown lowlights are fine. However, hair cannot be pink, red, gray, purple, etc.

#### Practice

Varsity- Hair up and out of your face for safety purposes and be mindful of length as it can also be a safety concern. No Hair Clips.

JV- Hair up and out of your face for safety purposes and be mindful of length as it can also be a safety concern. No Hair Clips.

#### <u>Games</u>

Varsity- Various hair styles including: Half Up Half Down, High Pony, Low Pony (per Coach depending on the game). Bow needs to be facing forward and bobby pinned upright or straight to the back depending on coaches want. Hair needs to be curled or straightened depending on game.

JV- High Pony unless the cheerleader has a short hair style that has hair falling above the shoulders in which they will do Half Up (per Coach depending on the game). Bow needs to be facing forward and bobby pinned upright. Hair needs to be curled or straightened depending on game.

#### Parades 199

Varsity- Half Up Half Down (per Coach depending on the parade). Bow needs to be facing forward and bobby pinned upright or straight to the back depending on coaches want.

JV- Half Up Half Down (per Coach depending on the parade). Bow needs to be facing forward and pinned. Hair needs to be curled or straightened depending on event.

#### Pep Rallies

Varsity- Various hair styles including: Half Up Half Down, High Pony, Low Pony (per Coach depending on the pep rally). Bow needs to be facing forward and bobby pinned upright or straight to the back depending on coaches want. Hair needs to be curled or straightened depending on event.

• Homecoming- Coaches choice.

JV- Various hair styles including: Half Up Half Down, High Pony, Low Pony (per Coach depending on the pep rally). Bow needs to be facing forward and pinned upright. Hair needs to be curled or straightened depending on event.

• Homecoming- Coaches choice.

#### **Competition**

Varsity- Various hair styles including: Half Up Half Down, High Pony, Low Pony (per Coach depending on the pep rally). Bow needs to be facing forward and bobby pinned upright or straight to the back depending on coaches want. Hair needs to be curled or straightened depending on event.

JV- Various hair styles including: Half Up Half Down, High Pony, Low Pony (per Coach depending on the pep rally). Bow needs to be facing forward and pinned upright. Hair needs to be curled or straightened depending on event.

\*\*\*Male Cheerleaders- styles and facial hair will be discussed with male cheerleader and coach on an as needed basis.

#### Make Up Expectations

**Practice** 

Varsity- No formal make up needed for practices unless notified by Coach.

JV- No formal make up needed for practices unless notified by Coach.

#### Games, Parades, Pep Rallies, & Competitions

Varsity & JV-Lips- Recommended Covergirl Clean Fresh Tinted Lip Balm in the color 400 - "You're the Pom" Eyes- Champagne or naturally colored eye shadow with some shimmer & Black Mascara (eye liner optional but simple only) Cheeks- light blush and highlighter

If make up is not worn for performances, cheerleaders are considered out of uniform and will be benched.

#### **Facial Piercings**

Facial piercings will not be allowed during performances or during practices for safety and uniforms reasons. Spacers will only be allowed during non-stunting activities. No exceptions will be made.

\*\*\*\*All hair and make up expectations are subject to change with notice per Coach. The coach will inform all squad members of changes to planned expectations as soon as possible.\*\*\*\*

## **DRESS CODE FOR TRYOUTS**

All candidates must wear:

- Plain white crew neck t-shirt (no visible logo)
- Solid black shorts
- White socks
- Athletic or cheer shoes
- Hair must be up in a secure high ponytail out of the candidate's face. To insure uniformity; no hair bows, ribbons, or any other accessories will be allowed.
- Natural makeup: at the very least, pink or red toned lips, blush or highlighter, natural eye shadow, & mascara.
- No jewelry allowed including facial piercings.

## TRYOUT DAY

#### Saturday, March 23, 2024 at Garland High School Time: Warm up in designated area - 12:30pm Time: Tryout Time - hoping to start between 1 -2pm

**These tryouts are closed to the public**. No parents or friends will be allowed in the building at any time during tryouts. No exceptions. Candidates do not leave until you are dismissed. Same rules will be applied to Mock tryouts.

Every attempt is made to hire judges that have not worked with students in the Garland area. However, with the hundreds of camps in the state of Texas, attended by thousands of cheerleaders and taught by hundreds of instructors, it may be possible at some time that a member of the judging panel may have had some contact with a candidate who is trying out. Professional judges with outstanding credentials and references will be hired for all tryouts. They will be instructed to judge the candidates based only on the mastery of the skills that they see demonstrated during the tryouts. Tryout results will not be challenged because of prior knowledge of judges and candidates.

## **TABULATION OF SCORES**

Each candidate will have a pre-score given to them by the director/coach.

Scoring - Each of the five judges will enter each candidate's scores into a spreadsheet. At the conclusion of the tryouts, a technical assistant will download all of the judge's individual score sheets into a master database. The score sheet will have a possible of 100 points and each candidate will be judged in following areas: Tumbling (10pts), Spirit (10pts), Jumps (30pts), Cheer (30pts), Dance (20pts)

When the tryouts are completed, only the campus administrator, technical assistant, and Fine Arts designee will be allowed in the tabulation location. When all scores are reviewed and ranked, the sponsors/coaches will be allowed to review the totals. No one else should be in the tabulation location. The district-wide formula for tabulating final scores should be as follows: Each judge may award up to 100 points total per candidate. The high and low judge's scores will be dropped, and the remaining three scores will be averaged together with the coach's score, to get the candidate's average score. In order to be placed on the cheer squad, after dropping the high and low scores from the judging panel and averaging with the coach's score, a candidate must earn 50 for varsity, 40 for JV A and JV B out of the possible 100 points and fall within the natural break.

HS Varsity – 50%

## **TRYOUT SEQUENCE OF EVENTS**

#### CANDIDATE NUMBERING (HIGH SCHOOL ONLY)

All varsity only candidates will be numbered first, followed by varsity or junior varsity candidates, and then finally any junior varsity only candidates.

#### **SEQUENCE OF EVENTS:**

#### FULL GROUP PERFORMANCE

ALL candidates should walk in and perform the dance and cheer as a group in that order. It should be explained that this is only so the judges can see what the material should look like and that they will not be judged at that time. Full-out jumps and tumbling is not necessary but certainly welcome during this demonstration. Judges should put their pencils down during this time.

#### **GROUP DANCE/CHEER:**

Groups should consist of 3 candidates. They will enter the gym so that they end up standing in numeric order from left to right (from the judge's viewpoint). There should be no tumbling or spirit during this time, only uniform walking. The Fine Arts designee will start the music for the dance. Once the nod has been given, the designated candidate should call for the group cheer to begin. Upon completion, the candidates should wait for the judges to finish scoring. The cheer will have a section(s) incorporating a jump(s) and/or standing tumbling (8-counts). Candidates will be scored based on difficulty and execution. Candidates will also be judged on their smile, motion technique, and voice projection during this time.

#### **INDIVIDUAL JUMPS:**

Following the group performance of the dance and cheer, candidates will perform their jumps. Each candidate must perform a toe touch, a right hurdler/herkie, and a left hurdler/herkie. It will be determined by the campus whether it will be a hurdler or herkie. This will be performed one candidate at a time.

#### **INDIVIDUAL RUNNING TUMBLING:**

Once the jumps have been completed, each candidate will be offered a chance to tumble. All candidates will move to behind the mat in the back of the gym. When this is completed, all candidates will exit the gym.

#### **TRYOUT MATERIAL CRITERIA:**

Criteria mentioned should be given to the clinic instructor upon hire.

Cheers should have a place for an 8-count incorporating a jump(s) and/or standing tumbling.

Dances should be no longer than 8 - 12 eight counts total.

## SOCIAL MEDIA CONTRACT
