Taxpayer Impact Statement

Pursuant to Texas Government Code 551.04(c)(2)

Section 551.043(c)(2) requires “a comparison of the property tax bill in dollars pertaining to the [median-valued homestead property] for the current fiscal year to an estimate of the property tax bill in dollars for the same property for the upcoming fiscal year if the proposed budget is adopted.”

Fiscal Year	Median-Valued Homestead	Tax Rate per \$100 of Value	Estimated Property Tax Bill
FY 2025 – 2026	\$216,045	\$1.1709	\$2,529.67
FY 2026 – 2027	\$237,649	\$1.1709	\$2,782.63

Based on the requirements of the above statement, the comparison is not reflective of accounts which are protected by a tax ceiling.
