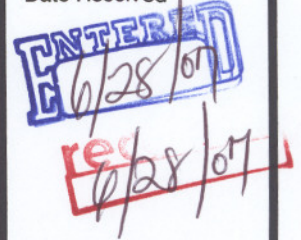
This questionnaire is being filed in accordance with chapter 176 of the Local Government Code by a person doing business with governmental entity.


