## **QUESTION:**

Will you be accepting electronic signed documents? Normally we still hand sign and upload to the bid. Can I use docusign for signature and upload to the bid?

### **ANSWER:**

Electronic signatures will be accepted for this solicitation

### **QUESTION:**

For clarification full case samples are required to be delivered by May 28th 2020.

Are there delivery restrictions on days samples are to be sent in like indicated in hard copies of bids for delivery?

## **ANSWER:**

Yes.

Schools are closed but the SNS warehouse is open for deliveries with exception of Memorial Day. You may call to set-up a sample delivery appointment at 972-487-4213.

### **QUESTION:**

Will garland accept Frozen Broccoli that is Import from Ecuador?

### **ANSWER:**

The preference is domestically grown. Price is also a factor and depends on if a domestically grown broccoli is bid. Please bid your product but notate that it is an import.

## **QUESTION:**

Will Garland ISD accept electronic signatures on signed documents for this RFP and all RFP's going forward?

## **ANSWER:**

Electronic signatures will be accepted for this solicitation

### **OUESTION:**

Yangs will be submitting a sample for the Refrigerated & Frozen bid #17-21. They have requested confirmation that samples will be able to be received while the schools are closed, either by direct ship or broker delivery.

**ANSWER:** Schools are closed but the SNS warehouse is open for deliveries with exception of Memorial Day. You may call to set-up a sample delivery appointment at 972-487-4213.

## **QUESTION:**

I have received questions from a few manufacturers regarding samples for both the Dry Staples and Refrigerated & Frozen bids. I have been asked to inquire if Garland ISD will accept partial cases, 1 or 2 packages of items, etc. This is strictly due to COVID-19 and these questions are coming from manufacturers that normally do not have a problem submitting full case samples. If you would consider approving this that would be appreciated.

### **ANSWER:**

That is acceptable due to COVID-19. We understand that manufacturing has been greatly affected as well. There still must be a minimum of 25 pieces or servings. Additionally, the partial cases must still be properly labeled with all item code information

### **QUESTION:**

With the safety precautions our company is taking with COVID-19 our corporate offices are closed and we are unable to enter, we are all working from our homes and I don't have access to representative to sign the bids. Are you willing to accept electronic signatures?

Can we provide quote for case size of 6 X 30# packs if the cost / pound is lower? If so, how should this larger size be documented?

### **ANSWER:**

Yes, however the smaller size is preferred. 6-#30 is more than needed. There is a field in the bid to state pack size.

# **QUESTION:**

I had a couple of questions on Bid #17 17-21 (32353). Would you happen to have the Current Vendor and Prices you are using for Items 29 and 30? These are the 4 oz cups of Apple Juice and Orange Juice. I was also wondering if these could be offered as shelf stable items? The bid states frozen and I didn't know if there was any leeway there. We have the cups that would be delivered as shelf stable and an option to freeze them. I appreciate any help you can give me!

## **ANSWER:**

There is a separate bid for Dry & Staples. This bid is for Frozen & Refrigerated items.
