Thanks so much! "Recently several premier assessment and analytics companies providing new options for Texas have been awarded large Assessment Management RFP contracts in the Lone Star State. In Section 8.2, there is a requirement for 3 years' experience for each of the two Texas references. This would exclude some of the most recognized student assessment companies available even though these solutions are proven and operational in TX, including Dallas ISD, San Antonio ISD and Richardson ISD. In order to provide your committee with the most innovative solutions to consider, what exceptions are you willing to make regarding the experience clause thus opening your choices to more than just one or two solutions?"
