Additional information shall be included and labeled according to page 16 **FORMAT OF PROPOSAL**. Ensure the company name, title and bid number appear on the outside of the submittal envelope. Furthermore, no faxed or emailed bids will be received. Your cooperation is appreciated.

1.2.3. MULTIPLE AWARDS

Add: Multiple awards are anticipated as companies may not be available on the dates needed for Garland ISD events.

FORMAT OF PROPOSAL: Proposals should be organized as shown below and should include all the information indicated below. Note that elaborate brochures or other presentations beyond those sufficient to present a complete and extensive response to this solicitation are not desired. The original documents shall be submitted and copies are not required.

SECTION A. INTRODUCTORY STATEMENT

- Provide a brief summary of the company to include number of years performing like services as requested in this RFP.
- Include proposer's experience and expertise in providing professional sound services
- Provide a minimum of three (3) references with contact information, reflecting similar work and related experience.
- Provide any documentation (certificates, diplomas, et. al.) that show the firm's training in the field of professional sound services

SECTION B. PRICE PROPOSAL (Submit completed pages 18 and 19 in this section)

Garland ISD has not identified a company for award to provide services for the convocation on August 3, 2023. Each response to this RFP must include a pricing catalog to include equipment and labor cost that will be used to price the convocation and other unscheduled events. In essence the company is required to provide a catalog of all equipment and labor rates that will be used for pricing all GISD events. The catalog should be completed using the format identified on page 18.

The district has identified a list of equipment and labor associated with a hypothetical event listed on page 19 which will be used to evaluate pricing component. The pricing listed on the catalog created on page 18 must be used for the pricing of this hypothetical event.
