**1. QUESTION:**

Should the Solutions' 1 and 2 start date be concurrent or start as per the RFP?

**RESPONSE:**

Solutions should start as per the RFP.

**2. QUESTION:**

For the tablets, do you have a mobile device management provider...if so, which one?

**RESPONSE:**

No, GISD does not currently have an MDM provider for our tablets.

**3. QUESTION:**

Are we allowed to submit bid for only one of the two solutions needed?

**RESPONSE:**

Yes; however, GISD is seeking both solutions from one provider.

**4. QUESTION:**

If we understand solution 1 correctly, your looking to purchase 300 Sim cards only with unlimited Hotspot data? Or 300 devices with Sim cards and unlimited Hotspot data?

**RESPONSE:**

Either is acceptable. If your company can provide 300 Sim cards only (no Hotspot devices) with unlimited Hotspot data that are compatible with T-Mobile Franklin T9 Hotspots, this is acceptable. Or, provide a solution that includes 300 Hotspots with Sim cards and unlimited Hotspot data.

**5. QUESTION:**

If we understand solution 2 correctly, your looking to purchase 310 Sim cards only, with unlimited tablet data plans?

**RESPONSE:**

Correct, but must be compatible with our Galaxy Tab Active3 tablets.

6. **QUESTION:**

Are the devices that you have unlocked so that they are compatible with any network provider?

**RESPONSE:**

The 300 T-Mobile Franklin T9 Hotspots may be locked. The 310 Galaxy Tab Active3 tablets should be unlocked. GISD will request a SIM Card for testing purposes in both devices.
