## 1. **QUESTION:**

Can you please advise when Spring break will commence and end? This information is necessary so samples are not sent during that time. Thank you.

## **RESPONSE:**

Garland ISD Spring Break is March 11-15.

## 2. <u>QUESTION:</u>

For line items of the 6/#10 cans of fruits where it indicates US preferred. Can you please confirm Garland is currently purchasing all Domestic?

## **RESPONSE:**

This question is not applicable to the bid.

## 3. <u>QUESTION:</u>

For Nationally known brands for example cereal General Mills, Kellogg's or Pioneer dry mixes are cases samples required?

## **RESPONSE:**

Yes samples are required.

Is E- sign, ok?

#### **RESPONSE:**

Yes. E-sign is allowed.

#### 5. <u>QUESTION:</u>

Do you require 1295?

#### **RESPONSE:**

The following language is in our RFP:

#### TEXAS HOUSE BILL 1295, CERTIFICATE OF INTERESTED PARTIES

If the individual contract/award exceeds \$1,000.000 or goes to the Board of Trustees, the person or entity submitting this proposal must comply with House Bill 1295 which is codified in the Texas Government Code \$2252.908 effective January 1, 2016, by submitting a completed and signed Form 1295, Certificate of Interested Parties within 10 days after notification of intent to award. The appropriate form and additional information is available from the Texas Ethics commission at www.ethics.state.tx.us/index.html.

#### 6. **QUESTION:**

Do you require a Certificate of Insurance, if so, what is the certificate holder's address?

#### **RESPONSE:**

Yes, Garland ISD does require a Certificate of Insurance. The certificate holder's address is 501 S. Jupiter Road Garland, Tx 75042.

#### 7. <u>QUESTION:</u>

Do you want a copy of our W9 uploaded as well?

### **RESPONSE:**

## 8. QUESTION:

Are full cases required for samples or will you accept partial cases, if partial cases are accepted what is the number of servings you need for testing?

## **RESPONSE:**

Yes, we will accept partial cases. Please provide enough servings to be tested by the committee.

#### 9. QUESTION:

Are you looking for re-sealable containers for the sauces?

#### **RESPONSE:**

This is not indicated on the bid line and therefore it is not a requirement.

Line 7 States CANNED JUICE SPARKLING, VARIETY FLAVORS, 100% JUICE, 8 OZ CANS. Can we bid a different size?

## **RESPONSE:**

Yes, you can bid a different size.

## 11. QUESTION:

Quote Minimum Release Amount - On Line Items, should this be the total dollar amount or number of cases?

## **RESPONSE:**

The minimum released amount can be based on either dollars, pounds or cases.

## 12. QUESTION:

Will Garland have a public bid opening?

## **RESPONSE:**

No, public bid openings are only required for BIDs.

### 13. QUESTION:

I need to send in samples, however, my samples comes from DOT Foods and not the warehouse. I do not have the ability to include paperwork, only on the invoice. Once I place the order, I can share the conformation email from DOT and also the tracking information once it ships out from DOT Foods.

## **RESPONSE:**

Paperwork may be submitted electronically.

## 16. <u>QUESTION:</u>

Is this bid for a direct shipment, shipped to one location (school or warehouse)?

## 23. QUESTION:

We're doing the dry goods (we make a peanut-free spread). I couldn't tell from the forms if it wants us to ship directly to the district or if Garland utilizes a distributor.

#### 24. QUESTION:

One question-- who is the distributor for Garland? This will help us fill out the pricing component, so we can take into account the distributor's margin.

#### 25. QUESTION:

Since the bid was extended, can you confirm when bid samples need to be delivered?

Samples are required for each item listed in this solicitation. Submit samples to: Food Service Dept, Attention: Nancy Davila, 701 N. First Street, Garland, TX 75040. Each individual sample must be clearly labeled with the bid number, company name, and the bid line item number of the item being submitted. Items for which the required information is not provided may be removed from consideration. Samples are due on or before March 22, 2024.

Can you please advise if we can submit multiple brands/manufacturers on line items? For example, we have 3 separate manufacturers, all meet the specs but have different pricing. Sample tasting I'd assume be determining factor.

## **RESPONSE:**

Yes, you may submit multiple brands. Please indicate alternates on the compliance form.

## 28. QUESTION:

Why does Garland insist to have full case samples be sent in every year when other large school districts in Texas wait until after bid opening to determine on which samples are required?

### **RESPONSE:**

We will accept partial cases. Please provide enough servings to be tested by the committee.

## 29. <u>QUESTION:</u>

Section F.4 of 'General Specifications' states 'All products proposed must be approved and registered with the Texas Department of Agriculture to be considered'. We are based outside of Texas and are approved by the Dept of Agriculture in our state. Will providing that certification suffice?

### **RESPONSE:**

Yes, providing a certification from your state will suffice.
