2. Question:

3. Question:

4. Question:

5. Question:

We would like to apply for both hardware and software, I see several lines for software, how do we make sure we can add our hardware on the RFQ?

You would enter hardware in the discount lines for items that don't have a line.

6. Question:

Would online tutoring fall under RFP 397-25-02 (Instructional Software, License Subscriptions, Hardware, and Services)?

Any software, hardware or services that doesn't have a line. Please list in the discounted line price for additional software, hardware, or services.

7. Question:

What is the process to update pricing after the first year?

Response:

Please review line 1.2.10 in Distribuion packet it states: Proposers are required to hold proposed prices for **90 days** from date of award. After this time, proposed increases may be submitted in writing for approval. Proof of change in market conditions must accompany a request for price increase. Any price increase request is subject to Purchasing Department review and approval. Increases may be submitted for approval but shall not exceed the Consumer Price Index.

8. Question:

Are the 4 renewal years automatic if both parties do not cancel?

Response:

Please review line 1.2.8 in Distribution packet it states; The term of the contract shall be from **December 11, 2024** (or date of award) through **December 11, 2025** with contract renewing annually for four years unless cancelled by either party as stated in CANCELLATION FOR CONVENIENCE or CANCELLATION FOR CAUSE.

9. Question:

After further reviewing the RFP, it seems only a discount percentage is required. Is pricing not required?

Response:

Pricing will be available to the lines item that are listed and discount percentage is for software, licensing subscription, hardware, and equipment that is not listed in the lines.

10. Question:

Is a 0% discount acceptable?

Response:

The discount is for additional software that is not listed in the line items.

11. Question:

If we offer instructional software and we are approved on bid 397-24-05: Online Instructional Software, do we need to submit for this bid?

Response:

It is up to your company to decide whether you want to place a proposal for this bid. This contract will hold unitl December of 2030

12. Question:

Should we respond to this bid if our contract for bid 334-18-01: Online Language Learning has expired, or will there be a better opportunity for a language learning bid?
